HOW IT WORKS

Purchase at a participating location between December 1, 2024, and March 31, 2025. Each receipt above \$10.00 will be eligible as one (1) entry for a chance to win one of ten \$500 gift cards* to any participating locations in one of the nine communities in Eeyou Istchee. Winners choose the business(es) (2 maximum), we buy the gift cards. Limit of five (5) entries per participant per day during the contest period. By accepting your winnings, you accept to have your name and photograph publicized on the contest website/app and Cree Nation Government – Department of Commerce and Industry Facebook page.

Draw categories:

- Retail grocery, gas, convenience
- Other

Draw frequency:

- Draw 1, for entries received from December 1- 31, 2024
- Draw 2, for entries received from January 1-31. 2025
- Draw 3, for entries received from February 1-28, 2025
- Draw 4, for entries received from March 1-31, 2025

Note, entries must be received by midnight on the last day of the month in which the purchase was made in order to be eligible for the draw.

Eligible businesses must be registered on the Cree Nation Business Registry & Opportunities platform or be a home-based Cree artisan. Eligible businesses must be located within the following communities:

Eenouch and Eeyouch can complete the contest entry form, including their full names, valid email address, and the date and location of the purchase. All entries will be entered into a draw, and winners will be randomly chosen. If they are selected, winners will be asked for a copy or photo of their receipt. Winners must answer a skill-testing question in order to receive the prize. No purchase is necessary, see full contest rules for details.

The Cree Nation Government – Department of Commerce and Industry may at its discretion ask for the receipt or proof of purchase. To ensure your eligibility, please responsibly keep your original receipts for the duration of the draw period.

OFFICIAL CONTEST RULES

- CONTEST SPONSOR: The Buy Eeyou Istchee Contest (the "Contest") is sponsored by the CREE NATION GOVERNMENT – DEPARTMENT OF COMMERCE AND INDUSTRY (the Contest Sponsor").
- 2. CONTEST PERIOD: The Contest begins at 12:00 a.m. EDT on December 1, 2024, and ends on March 31, 2025, at 11:59 p.m. EDT.
- 3. DRAW FREQUENCY: The contest is divided into three (3) separate draw periods, unless otherwise stipulated:
 - a. December 1-31, 2024
 - b. January 1-31, 2025
 - c. February 1-28, 2025
 - d. March 1-31, 2025

At the end of each draw period, all eligible entries received during that specific period will be entered into a draw, and one winner will be chosen for each category. Please note that the selection periods are subject to change at the discretion of the Contest Sponsor.

- a. ENTRY THROUGH THE CONTEST APPLICATION: Make a purchase of at least \$10 (excluding alcohol) at a participating location between December 1, 2024, and March 31, 2025. Each receipt above \$10.00 will be eligible as one (1) entry for a chance to win one of ten \$500 gift cards* to any participating locations in one of the nine communities in Eeyou Istchee, on us. Visit www.CreeKeepitLocal.ca or download the Keep it Local app on your smartphone and complete the contest entry form with your full name, valid email address, date and location of the purchase. Participants must keep the original receipt.
- b. ENTRY BY SHORT ESSAY: Write an essay of 50 words on the benefits of shopping locally and mail it to: Cree Nation Government Department of Commerce and Industry, 284 Queen Street Suite 201, Mistissini, QC GOW 1C0. Each essay received will entitle the author to one entry into the draw off their choosing. Applicants must include their full names, valid email addresses, telephone numbers, and the draw category they wish to enter.
- c. All entries will be entered into a draw and winners will be chosen at random. Winners may be asked for a copy of their original receipt if they are selected. Limit of five (5) entries per participant, per day during the contest period. A day is defined as 12:00 a.m. EST to

- 11:59 p.m. EST. Any attempt or suspected attempt to use robotic, automatic, programmed, or otherwise, illicit means to enter the Contest, shall be deemed as tampering and may disqualify you from entering, participating and/or winning a prize. Entries that contain false or incomplete information, or are deemed inappropriate due to profanity, vulgarity, or defamation are void.  - b. The winner will be emailed the skill-testing question and must answer correctly.
 - c. If the winner is under 18 years of age, they will be asked to have their parent or guardian complete the Parental Consent Form.
 - d. The winner will choose one of the following:
 - i. One \$500 gift card to the participating business of your choice.
 - ii. Two gift cards totalling \$500 at the participating businesses of your choice.
- 9.
